

## AGREEMENT-NOTIFICATION

### On the collection and processing of personal data

I, as a subject of personal data, in compliance with the requirements of the Law of Ukraine "On the Protection of Personal Data", by signing this text, I grant to the Limited Liability Company "BLS INTERNATIONAL SERVICE" (hereinafter - the Company), its unambiguous, implicit and irrevocable consent to commit the Company, As the owner of personal data, all actions that, in accordance with the Law of Ukraine "On Protection of Personal Data", are processing of my personal data in accordance with the formulated purpose of their processing, in particular:

1. collection and processing of personal data by their inclusion in the Visa Information System of the Schengen States (VIS) and transfer of personal data to the consular post of the Embassy of the Kingdom of Spain for further processing and decision-making on issuing a visa document;

2. processing of personal data within 30 days;

3. on making changes to personal data in case of their change or necessity of addition;

4. commit other actions related to the processing of personal data in accordance with the purpose of their processing and the requirements of the current legislation of Ukraine.

The purpose of processing the personal data provided is the processing of visa documents for entry/departure to the Kingdom of Spain and other countries of the Schengen agreement.

The following personal data may be processed by the Company for the purpose of processing personal data:

Surname, name and patronymic; Date of birth, place of birth, country of birth; citizenship; sex; Civil status; Address of residence (stay), information on residency; The series and number of the general civilian passport, the date of issue and the authority that issued it; Contact phone; Digitized signature; fingerprints; photo.

I will certify that I have been notified of the inclusion of my personal information in order to provide me with visa registration services for entry to/departure from the Kingdom of Spain and other countries of the Schengen Agreement in accordance with the requirements of European Commission Regulation No. 2015/731 of 06.05. 2015 on the determination of the date of entry into force of the Visa Information System (VIS) in the 17th and 18th regions, the Visa Code of the Schengen Area and the Agreement between Ukraine and the European Community on visa facilitation, as well as about my rights, definitions These are the Law of Ukraine "On Protection of Personal Data" and the persons to whom my data are provided, in order to accomplish this purpose.

Also, I have been informed that the place of personal data storage is at the following address: Kyiv, street. Illinskaya, 8, as well as that the owner and manager of personal data is Limited Liability Company "BLS INTERNATIONAL SERVICE".

I agree and do not require to make a separate communication about the processing (distribution) of my personal data, if such processing (distribution) is solely for the purpose of providing me with the services of registration of visa documents for entry to/departure to the Kingdom of Spain and other countries of the Schengen Agreement In accordance with the requirements of European Commission Regulation No. 2015/731 dated 06/05/2015 on determining the date of entry into force of the Visa Information System (VIS) in the 17th and 18th regions, the Visa Codes of the Schengen Area and the Agreement between Ukraine and the European Community visa facilitation and according to the Law of Ukraine "On Personal Data Protection" and their destruction after the retention period specified herein.

### Article 8 of the Law "On Protection of Personal Data". Rights of the subject of personal data

1. Personal non-proprietary rights to personal data held by each individual are inalienable and unalterable.

2. The subject of personal data is entitled to:

1) to know about the sources of collection, the location of their personal data, the purpose of processing, the location or residence of the owner or the administrator of personal data or to give a corresponding order to obtain this information for authorized persons, except in cases established by law;

2) to receive information about the conditions for granting access to personal data, in particular information about third parties to which his personal data are transferred;

3) access to their personal data;

4) receive no more than thirty calendar days from the date of receipt of the request, except in cases provided by law, the answer as to whether his personal data is processed, and also to receive the contents of such personal data;

5) make a motivated request to the owner of personal data with the objection against the processing of his personal data;

6) make a motivated request for the modification or destruction of their personal data by any owner and manager of personal data, if these data are processed illegally or are unreliable;

7) to protect their personal data from unlawful processing and accidental loss, destruction, damage due to intentional concealment, failure to provide or untimely provision thereof, as well as protection against providing information that is unreliable or defamatory of honor, dignity and business reputation Physical person;

8) to file complaints about the processing of his personal data to the Commissioner or to a court;

9) to apply remedies in case of violation of the legislation on protection of personal data;

10) make reservations regarding the limitation of the right to process his personal data at the time of the consent;

11) withdraw consent for the processing of personal data;

12) know the mechanism of automatic processing of personal data;

13) to protect against an automated solution that has legal implications for it.
